ENGLISH LAW

- Law made by Parliament - This is UK domestic legislation, referred to as 'Act' or 'Statutes'. Written law that expresses the will of the legislature.
- Law decided in courts - Referred to as 'Case Law' or 'Common Law'. Decisions of judges in particular cases applied by other judges in later cases through the process of precedent.

Chapter 1 INTRODUCTION TO LAW AND THE LEGAL SYSTEM

In most of the English-speaking world, the legal systems are based upon English common law. Common law works on precedents, established by judges that date from early in English history. By the 17th century, statutes enacted by Parliament took precedent over common law. That is statutory law prevailed, and legislation became more important.
